HOSTEL RULES AND REGULATIONS: -

All students/residents shall strictly follow the following Hostel Rules and Regulations. Any violation shall attract appropriate disciplinary action as per the rules of the Institute.

Sl. No.	Hostel Rule / Violation	Fine / Disciplinary Action
1	Ragging in any form is strictly prohibited within or outside the hostel premises.	Fine up to ₹10,000/- and other action including suspension/expulsion/rustication as applicable.
2	Creating nuisance, shouting, making excessive noise or disturbing other residents.	Fine up to ₹5,000/-
3	Playing music/TV/audio systems at a volume that causes disturbance to other residents.	Fine/disciplinary action as decided by the Competent Authority.
4	Consumption of alcohol or causing nuisance under the influence of alcohol in the hostel.	Fine up to ₹5,000/- and/or expulsion/rustication.
5	Possession, consumption, sale or distribution of illicit/prohibited drugs or intoxicating substances.	Strict disciplinary/legal action , including cancellation of hostel allotment and expulsion/rustication.
6	Smoking or use of tobacco/tobacco products in the hostel or Institute premises.	Fine/disciplinary action as decided by the Competent Authority.
7	Cooking, boiling, baking or microwaving in hostel rooms where such activities are prohibited.	Fine up to ₹1,000/- for first offence and up to ₹5,000/- for second offence.
8	Use of unauthorized/high-power electrical appliances such as heaters, air-conditioners, etc.	Fine up to ₹5,000/- and recovery of damage, if any.
9	Causing damage to hostel furniture, fixtures, fittings or other institutional property.	Recovery of actual damage + fine up to 3 times the cost of damaged property.
10	Vandalism, graffiti, writing on walls or damaging hostel displays.	Recovery of damage + fine up to 3 times the cost of damage.
11	Pasting posters or notices on hostel walls/displays without authorization.	Fine/recovery of damage as applicable.

12	Moving hostel furniture, fixtures or furnishings from one room/place to another without permission.	Fine/recovery of damage and/or cancellation of hostel allotment.
13	Allowing an unauthorized/non-allotted student or person to stay in the hostel room.	Cancellation of hostel allotment and/or expulsion/rustication.
14	Sub-letting hostel accommodation or allowing a proxy/dummy roommate.	Cancellation of hostel allotment and/or expulsion/rustication.
15	Bringing unauthorized or unknown persons into the hostel premises.	Fine/disciplinary action as decided by the Competent Authority.
16	Allowing visitors/parents/relatives into hostel rooms without prior permission where such permission is required.	Fine/disciplinary action as decided by the Competent Authority.
17	Organizing parties, celebrations or gatherings without prior permission of the Hostel Superintendent/Hostel warden.	Disciplinary action, including restriction/expulsion from hostel where warranted.
18	Misbehaving with, abusing, threatening or showing disrespect to hostel staff/security personnel/institute officials.	Disciplinary action, including written apology/report to Dean or Director.
19	Physical assault, violence or causing physical/mental harm to another person.	Strict disciplinary/legal action, including suspension/expulsion as applicable.
20	Possession or use of weapons, replicas of weapons or dangerous articles/materials.	Strict disciplinary/legal action, including expulsion where warranted.
21	Dangerous driving, risky behaviour or any act causing fire/safety hazards in hostel premises.	Fine up to ₹1,000/- for first offence; up to ₹5,000/- for second offence, with further action if required.
22	Keeping hazardous materials, fire-risk materials or prohibited substances in hostel rooms.	Fine/disciplinary action as decided by the Competent Authority.
23	Littering, improper disposal of garbage, maintaining unhygienic conditions or causing unnecessary wastage of water/electricity.	Fine/disciplinary action as decided by the Competent Authority.

24	Violation of hostel leave, outstation permission, entry/exit restrictions or movement-register requirements.	Fine/disciplinary action as decided by the Competent Authority.
25	Keeping pets, feeding stray animals or committing any other act of indiscipline/violation of hostel rules.	Cancellation of hostel allotment and/or expulsion/rustication, as applicable.

GENERAL CONDITIONS

1. The above fines shall be imposed **only by the competent authority** in accordance with applicable Institute rules and disciplinary procedures.
2. Where hostel property is damaged, the **actual cost of repair/replacement shall be recovered separately**, in addition to any applicable fine. The existing manual permits recovery up to three times the cost of damaged property.
3. Serious offences may attract **more than one disciplinary action**, including fine, recovery of loss, cancellation of hostel allotment, suspension, expulsion/rustication and legal action.
4. **Ragging is strictly prohibited** and shall be dealt with under the applicable anti-ragging regulations and institutional directions.
5. All students shall maintain discipline, cleanliness, safety and the dignity and good name of **AIIMS Madurai**.
6. Ignorance of the Hostel Rules and Regulations shall not be accepted as a justification for violation.
7. The Hostel Rules may be modified/amended by the **Competent Authority** from time to time.
